# Role of a School District's Mentor

REACH

The District/School should assign the Mentor Role to the school personnel that will be proactive daily with the students, parent/guardian, leadership, and Edgenuity teachers. Mentors are intended to be the main connection between Edgenuity instructors and your students. **Please identify the mentors prior to the Implementation Meeting.**

- Enforce program guidelines and express expectations for participation.**
- Access the student and parent.**

## Credit-Recovery vs. Initial Credit

The NCAA does not accept different versions of core courses for credit recovery. A student who wishes to recover credits must take the same course as students earning initial credit. Although you may offer credit recovery versions of Edgenuity courses at your school, those courses are not NCAA-eligible.

## Length, Content, and Rigor

Edgenuity courses are equivalent to face-to-face courses in length, content, and rigor. Core courses in English Language Arts, Mathematics, Science, Social Studies, and World Languages have been reviewed and approved by the NCAA as meeting its definition of a “core course.” In addition, both Intro to Philosophy and World Religions have both been approved for use with Instructional Services only.

## No Pretesting or Prescriptive Testing Allowed

## Student can not complete the course before the End Date

- 12 weeks minimum for Fall/Spring Semester
- 6 weeks minimum for Summer Semester

## Edgenuity's Academic Integrity Policy

### 1st offense

Warning

Educate student about plagiarism.

Provide an additional attempt.

### 2nd offense

Alert student, mentor, and parent/guardian.

Provide an additional attempt if student submits understanding of plagiarism.

### 3rd offense

No additional attempts.

Possible further disciplinary action.

# White List (Installation & Permissions REQUIRED)

## White List

List district provides to the IT Department.

Contains all websites **required** for Edgenuity's platforms function correctly.

## 80% Completion Justification

- In standard classrooms, teachers often do not get through entire textbooks. Since our courses are set up similarly to textbooks, the 80% complete standard takes this into account.

## Overall Grade

The student's **mastery grade**. It reflects how they are performing on the work they are completing. No points are subtracted for pacing.

## Actual Grade

The student's **current grade** in the course. Points will be subtracted for falling behind in their pace.

At the end of the course the student's Actual Grade and Overall Grade should be the same score.

# Extra Testing Options

## Pretesting

- This is normally used for Credit Recovery to test out of lessons and move forward from what the students have already learned.

## Prescriptive testing

- Prescriptive testing works by generating an assessment that the student takes at the very beginning of the course. As such, it can only be enabled before the student has started the course.

***NCAA students cannot utilize pre-testing or prescriptive testing.***





